## **For what purpose do we process your personal data?**

At WILD ALASKA SALMON, S.L. We treat your data with the main purpose of maintaining our agenda of contacts,

a) As a contact person to maintain relations with the legal entity or organization in which you Prest your services.

b) As an interested party who has contacted us consulting us or requesting any information, to be able to serve you.

As an additional purpose, if authorization has been requested and granted to us, We will process your data to send commercial communications.

## **How long will we keep your data?**

The personal data provided will be kept for the main purpose:

a) In the case of a contact person to maintain relations with the legal entity or organization in which you provide your services, will be kept as long as our relationship with said entity is maintained legal or organization, and except for the legal deadlines for the legal responsibilities that may arise from the relationship with the legal entity or organization.

b) In the event of an interested party contacted us, up to 6 months after meeting your request, in case there are subsequent communications on your part in reference to said consultation or request of information.

In the additional purpose of sending commercial communications, we will keep your data as long as we do not express your opposition to continue receiving our communications.

## **What is the legitimacy for the processing of your data?**

The legal basis for the treatment of your data in the main purpose of maintaining the contact book is

a) In the case of a contact person to maintain relations with the legal entity or organization in which you provide your services, is the satisfaction of the legitimate interest of the person in charge, in accordance with established in art. 6.1.f of the RGPD.

b) In the case of an interested party contacted us, the legal basis is to obtain their consent.

In the additional purpose of sending commercial communications, the legal basis for the processing of your data is obtaining your consent.

## **To which recipients will your data be communicated?**

During the duration of the treatment we will not communicate your data to third parties.

At WILD ALASKA SALMON, S.L. We will have the collaboration of third-party service providers that in each case we have been able to contract and that, for the provision of said service, it may be necessary that they have access

to your personal data, but that they will be treated with all the legal guarantees required, following our instructions and prior subscription of a data protection contract in which we demand, among others, to treat the data exclusively for the agreed purposes, apply appropriate technical and organizational measures, as well as

delete and return the data at the end of the service.

### **What are your rights when you provide us with your data?**
